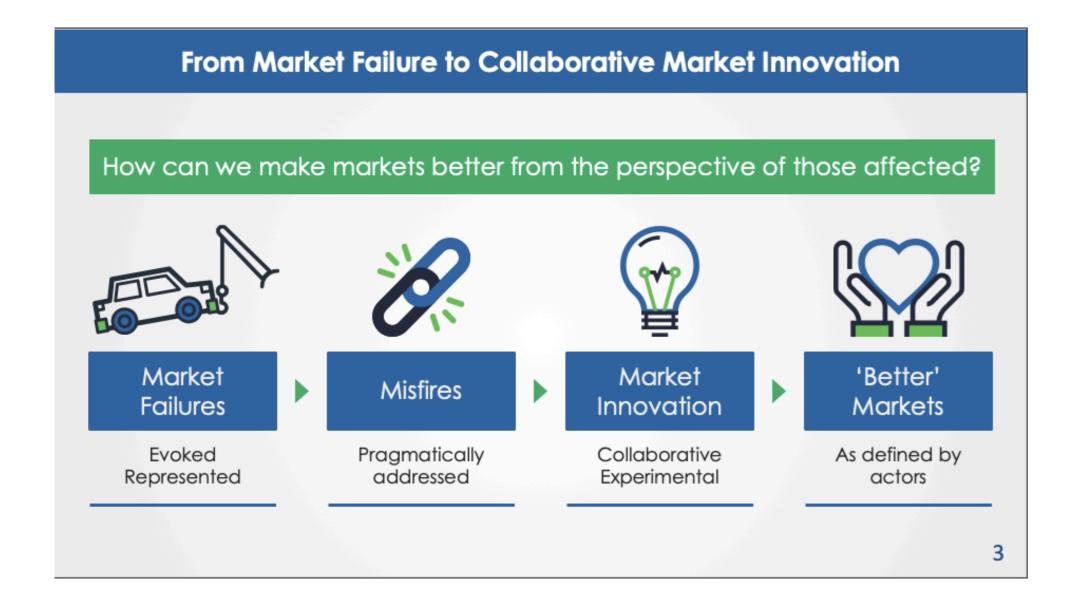


BACKGROUND

'MISFIRES' is a new interdisciplinary ERC funded research program at the intersection of STS and critical market studies, based at University College Dublin. It aims to guide new academic and policy thinking by establishing how:

- concerned actors voice and mobilise around the notion that healthcare market has 'failed' them;
- concerned actors seek to negotiate and address healthcare market failures;
- 3) this process may lead to 'better' healthcare markets (as defined by the actors).

The project explores participatory and collaborative strategies in the five cases it researches by helping to open these markets up to the concerns of those who are let down by them.



AIMS AND OBJECTIVES

MISFIRES asks how actors can engage with a market's failures to challenge its organisation and make it more collaborative, more open to civic values and to social or political concerns. It takes healthcare markets as prototypical examples of 'concerned markets' (Geiger et al., 2014), characterised by diverse interests of multiple actors, significant social and political stakes, and a long tradition of collective action

EPISTEMIC GOALS: to establish what makes markets 'better' or more 'civilised' (Callon 2009) from the perspective of those let down or marginalised by them, and what actions these actors can take to open up the healthcare markets to their concerns.

PRACTICAL GOALS: to devise roadmaps to overcome current economic, institutional and political constraints that preserve healthcare markets' status quo, helping to build an inter-stakeholder dialogue around how to make health markets better, one misfire at a time.

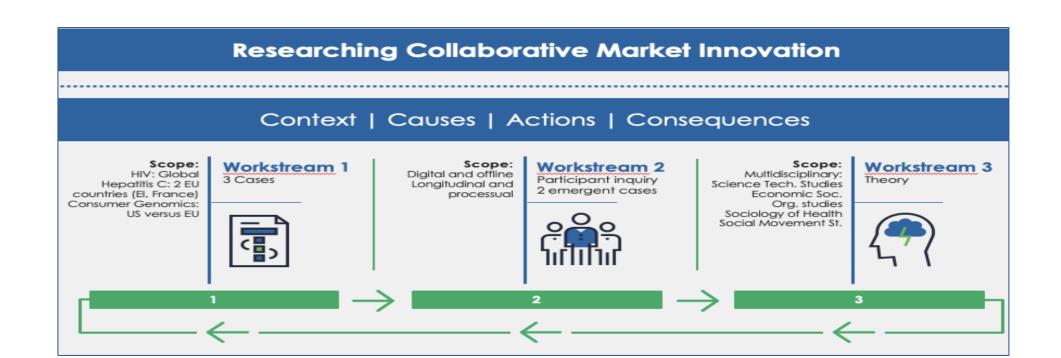

RESEARCH DESIGN



MISFIRES will pioneer new theoretical and empirical horizons for understanding and conceptualising a collaborative turn in market organisation.

Three co-evolving work streams:

- **Empirical engine INVENTORIZING** Healthcare activism across paradigmatic cases of collaborative innovation in healthcare markets
- Methodological innovation FOLLOWING following the formation of concerned publics in emergent cases
- **Conceptual development THEORIZING** and practicing collaborative market innovation
